7. Decision to be made on whether to have/where to place a one ton salt bag. After discussion it was resolved to place the salt bag at the top of Boughton Hill in the lower corner of the layby below Boughton Place Cottages, out of view from the lane down to the lay by.

Cllr Turner proposed the above with the proviso that if it is used, an actual salt bin will be provided next year; Cllr Galton seconded; unanimous agreement.
