This application covers part of the site for which consent to application MA 10 / 2029 was granted with condition 22 requiring development to be carried out in accordance with the GREAT CRESTED NEWT SURVEY AND MITIGATION REPORT submitted in 2012.

Appendix 3 of that report contains a map showing proposed mitigation measures which will be affected by this application and the Boughton Malherbe Parish Council requests conditions are applied to any approval given to the effect that:

- a) The tree and hedgerow planting and area of created rough grassland and scrub approved under MA 10 / 2029 shall be preserved by suitable amendment so as not to be compromised by this application.
- b) The work shall be carried out in such a way and at such a time so as not to have any impact upon the nearby great crested newt colony at Liverton Hill Farm during the activity season.

Subject to satisfactory relocation of the 30MPH sign currently in the area of land proposed to be altered for the wider access and the work being carried out to the satisfaction of the KCC Highways Dept. the Boughton Malherbe Parish Council has no objection to this application.
