3. **Approval of the Minutes of the Meeting on 11th November 2014:** having been previously circulated, the Minutes were approved and signed.

4. **Matters Arising**

Cllr Turner: it is now known that KCC Highways engineer John Reynolds has moved on, hence no response from him re flooding in Crumps Lane.

Woodcock Lane – spoken twice to Highways Steward, no response. Ditch needs digging out.

Last minutes - hadn't heard from John Burr by the last meeting; he has since responded, and stated £30,000 had been spent on resurfacing Liverton Hill!!!!!! Re gullies, he stated that as there had been no reports of flooding on the hill, cleansing had been altered from 6 monthly to annually.

In thick fog it is difficult to drive without white lines, however, white lines, though it is now known that they are not applied to roads less than 5.5 meters wide. It is considered that Crumps corner needs doing on safety grounds.

The surface of Liverton Hill is breaking after frosts and rain and the whole road is looking very bad; Martin Round to pursue this issue with Jenny Whittle, KCC.

6.1 Police Report

There were no crimes to report for this period. There were 3 calls to the police involving an abandoned vehicle, a found dog and a suspect person.

Report from Stuart Ellesmere, Community Warden: Here is an update of what I have been up to in the Grafty Green/Boughton Malherbe area:

- I have been working closely with PCSO Boyd on local issues and have provided a visible presence on four occasions. (On foot)
I have also driven around the Village on three occasions.
- Both PCSO Boyd and I have been to see residents on Liverton Hill to help setup a Neighbourhood Watch Scheme there
- I have received no more reports of dangerous driving through the Crumps Lane area.
- I have met up with Cllr Round on a few occasions since my last report. We have also discussed the possibility of using the village Hall as regular surgery venue
- As you were probably made aware via the media – it appears that the Community Warden Service will not be suffering any cuts to the Wardens who are based in their areas There will be changes occurring on the Management front with possible logistical 'movement' of staff as a result. I am hoping that this will not impact the current service levels too much.

6.2 Speedwatch Report

No Speedwatch has been carried out of late, will be resumed when the weather improves.

7. KFRS

Chris Wheal gave a report – there are massive financial cuts and everybody is stretched, not just KFRS.. Prevention and resilience are vitally important. Working with elderly and vulnerable.

8.1 Liverton Hill

There is a petition about weight restriction which is going well. It will be presented to the JTB in April. The one pothole at the bottom is now four and getting deeper resulting in complaints.

8.2 Pot holes in Colbridge Lane; tarmac around a drain cover – half way up dip towards Great Humphries. (Also streams 'raging torrents' here and at Calcott.

8.3 Ditches and gullies

Emstone Hole Road - KCC said banks need resolving before road and water sorted. Banks are private.

Church Road slippage repair – will be done in April after lambing - approximate cost £75,000

8.4 HGV Weight Restrictions- covered previously.
